A RESOLUTION TO RECOMMEND TO THE SCHOOLS DIVISION SUPERINTENDENT TO AWARD THE PROJECT SUPPLY OF MEALS, SNACKS AND VENUE FOR THE TWO-DAY TRAINING ON CLINICAL SUPERVISION USING 4AS AS METHODOLOGY FOR PUBLIC ELEMENTARY AND SECONDARY SCHOOL HEADS, DEPARTMENT HEADS AND MASTER TEACHERS ON MARCH 28-29, 2023 WITH 336 PARTICIPANTS TO BALANGHAI HOTEL & CONVENTION CENTER CORPORATION THROUGH NEGOTIATED PROCUREMENT (LEASE OF REAL PROPERTY AND VENUE)

WHEREAS, upon examination of supporting documents required for the procurement of Supply of Meals, Snacks and Venue for the Two-Day Training on Clinical Supervision Using 4As as Methodology for Public Elementary and Secondary School Heads, Department Heads and Master Teachers on March 28-29, 2023 with an Approved Budget for the Contract (ABC) of PhP 450,000.00 under PR No. 23-03-057, the committee finds that the purchase was in accordance with the provision of IRR Rule Section 53.10 of THE 2016 REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 9184 with the following reasons:

1. The above procurement does not fall under shopping in Section 52 of 2016 revised IRR of RA 9184;
2. The said procurement is considered as NEGOTIATED PROCUREMENT (LEASE OF REAL PROPERTY AND VENUE) which falls under Section 53.10 of revised IRR the Negotiated Procurement provisions;
3. The prices offered by the Contractor are most advantageous to the government.

WHEREAS, the BAC, upon recommendation from the technical evaluator and upon due deliberation of the submitted price quotations, determined that **BALANGHAI HOTEL & CONVENTION CENTER CORPORATION** to have the lowest calculated and responsive bid with a total bid amount of **Five Hundred Four Thousand Pesos Only (PhP 504,000.00)**;

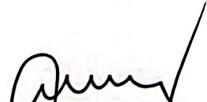

NOW THEREFORE, on unanimous accord of all members present.

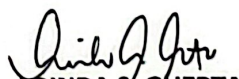
