BAC RESOLUTION NO. 70-2023

A RESOLUTION TO RECOMMEND TO THE SCHOOLS DIVISION SUPERINTENDENT TO AWARD THE PROJECT SUPPLY OF MEALS WITH VENUE FOR THE HALF-DAY MEETING RE: COA-DIVISION OF BUTUAN CITY EXIT CONFERENCE ON MARCH 8, 2023 TO ALMONT HOTEL & INLAND RESORT THROUGH NEGOTIATED PROCUREMENT (LEASE OF REAL PROPERTY AND VENUE)

WHEREAS, upon examination of supporting documents required for the procurement of **Supply of Meals with Venue for the Half-Day Meeting re: COA-Division of Butuan City Exit Conference on March 8, 2023** with an Approved Budget for the Contract (ABC) of **Php 57,475.00** under **PR No. 23-03-046**, the committee finds that the purchase was in accordance with the provision of IRR Rule Section 53.10 of **THE 2016 REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 9184** with the following reasons:

1. The above procurement does not fall under shopping in Section 52 of 2016 revised IRR of RA 9184;
2. The said procurement is considered as **NEGOTIATED PROCUREMENT (LEASE OF REAL PROPERTY AND VENUE)** which falls under Section 53.10 of revised IRR the Negotiated Procurement provisions;
3. The prices offered by the Contractor are most advantageous to the government.

WHEREAS, the BAC, upon recommendation from the technical evaluator and upon due deliberation of the submitted price quotations, determined that **ALMONT HOTEL & INLAND RESORT** to have the lowest calculated and responsive bid with a total bid amount of **Fifty-Seven Thousand Four Hundred Seventy-Five Pesos Only (Php 57,475.00)**;

NOW THEREFORE, on unanimous accord of all members present.
